

Basi Network Connect! – Affiliation Agreement

Terms Addressed

1. **Affiliate:** The applicant or division of the applicant's business or organisation;
2. **Basi:** Business Advisory Services Incorporated – NSW Association #: Y1944213.

Conditions

1. All affiliates are aware that their event will be endorsed by Business Advisory Services Incorporated (herein referred to as "Basi") after approval is granted by the Basi Board of Directors or their appointed Representative. Upon approval, the listing will be posted on the "Basi Network Connect!" section of the Basi Website;
2. The affiliate's event will be posted on the "Basi Network Connect!" section of the Basi Website. As this listing grows, it is anticipated that an entirely separate website will be developed;
3. At this stage and until notice is given (if at all), there will be **no charge** for affiliates to list their event with "Basi Network Connect!";
4. It is **anticipated** that a monthly e-newsletter will be developed and circulated to all clients listed on the Basi database - circulation of approximately 6,000 recipients. This newsletter will promote all affiliates and their events listed on "Basi Network Connect!";
5. Basi reserves the right to terminate any affiliate listing promoted through "Basi Network Connect!" at **any time and without condition or notice**;
6. Affiliates reserve the right to terminate the "Basi Network Connect!" affiliation at any time. Termination of the affiliation must be made in writing (electronic or standard) to Business Advisory Services Incorporated. Once acknowledged, the **affiliate will allow up to fourteen business days** for all affiliate information to be removed from circulation;
7. Affiliates are required to include the hyperlink, www.basinetworkconnect, to the "Basi Network Connect!" section of the Basi website within 14 days of the affiliates networking event being listed with "Basi Network Connect!". The **link must be attached to the "Basi Network Connect!" icon**, which will be provided after successful listing of the affiliate's event. Failure to adhere to this condition will result in Basi terminating the affiliation;
8. Affiliates are encouraged to extend any discount available for their event to all current financial Basi Members;
9. All affiliates are aware that listings are posted in order of approval;
10. All affiliates are aware that "Basi Network Connect!" will aim to promote business events held throughout Australia;
11. All affiliates are invited to contribute to the proposed monthly e-newsletter;
12. It is proposed that affiliates will be given access to a restricted area of the Basi Website to discuss "Basi Network Connect!" items and eventually provide input into the approval of new affiliate applications.
